A RESOLUTION AMENDING THE CITY OF ROGERS 2018 BUDGET TO APPROPRIATE THREE HUNDRED SIXTY-EIGHT THOUSAND TWO HUNDRED SEVENTY-THREE DOLLARS (\$368,273.00) FROM COMMUNITY DEVELOPMENT BLOCK GRANT FUND RESERVES TO VARIOUS ACCOUNTS; AND FOR OTHER PURPOSES.

WHEREAS, the City of Rogers has been awarded grant funds, rebate refunds, and deferred loan agreements in 2017 for the Community Development Block Grant (CDBG). The remaining grant funds from 2017 in the amount of three hundred fifty-six thousand one hundred forty-one dollars (\$356,141.00) and rebates and deferred loan agreements in the amount of twelve thousand one hundred thirty-two dollars (\$12,132.00) require an appropriation in 2018 for spending.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ROGERS, ARKANSAS THAT:

<u>Section 1</u>: The sum of three hundred sixty-eight thousand two hundred seventy-three dollars (\$368,273.00) is hereby appropriated from the CDBG Fund to the following accounts in the following amounts:

AN ORDINANCE ASSIGNING RECENTLY ANNEXED TERRITORY KNOWN AS "CERTAIN LANDS EAST OF HIGHWAY 112" TO CITY WARD 3; PROVIDING FOR THE EMERGENCY CLAUSE; AND FOR OTHER PURPOSES.

WHEREAS, the Rogers City Council referred Ordinance No. 17-52 to the citizens of Rogers and to the citizens living in certain territory known as "Certain Lands East of Highway 112" regarding the question of annexation of the said territory;

WHEREAS, an election was held on said question on November 14, 2017;

WHEREAS, the voters approved the annexation of said territory into the City of Rogers; and

WHEREAS, the Benton County Election Commission has certified the results of said election;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ROGERS, ARKANSAS THAT:

<u>Section 1</u>: Pursuant to A.C.A §14-40-303(d) the annexed territory known as "Certain Lands East of Highway 112" on the map of territory to be annexed submitted to the Benton County Clerk, and the Benton County Election Commission is hereby assigned to Ward 3 of the City of Rogers, Arkansas;

<u>Section 2</u>: The said "Certain Lands East of Highway 112" shall hereafter be considered and be a part of the City of Rogers, Arkansas as fully as any other part of the city;

<u>Section 3 - Emergency Clause:</u> The need to assign the said "Certain Lands East of Highway 112" a city ward is immediate and in order to protect the public peace, health, safety, and welfare an emergency is hereby declared to exist and this Ordinance shall be in full force and effect from the date of its passage and approval;

<u>Section 4 - Severability Provision:</u> If any part of this Ordinance is held invalid, the remainder of this Ordinance shall continue in effect as if such invalid portion never existed; and

<u>Section 5 - Repeal of Conflicting Provisions</u>: All ordinances, resolutions or orders of the City Council, or parts of the same, in conflict with this Ordinance are repealed to the extent of such conflict.

<u>Section 1:</u> The City of Rogers Offices of Finance, Human Resources, and City Clerk/Treasurer should be, and hereby are authorized to destroy the following records of the City of Rogers under Arkansas Code Annotated § 14-59-114 and City of Rogers Municipal Code § 2-1:

- (a) Audited records four years or older (Year 2012 and prior years): Canceled checks, voided checks, invoices, bank statements, receipts, receipts listings, deposit slips and daily deposit spreadsheets, bank reconciliations, check book registers or listings, monthly financial reports, budget documents, bids and quotes documents, insurance invoice, COBRA administration billings.
- (b) Audited records seven years or older (Year 2009 and prior years): Investment records, certificate of deposit records, journals, ledgers, subsidiary Ledgers, yearly (annual) financial reports, payroll timesheets, statements of financial interest, oaths of office, business licenses, ABC applications, business licenses exemptions, airport grants, ambulance service billing, expired lease documents, dog licenses, Fire Act 833 documents, insurance documents, and police department accident reports. <u>Section 2 Severability Provision</u>: If any part of this Resolution is held invalid, the remainder of this Resolution shall continue in effect as if such invalid portion never existed; and

<u>Section 3 - Repeal of Conflicting Resolutions:</u> All resolutions or orders of the City Council, or parts of resolutions or orders of the City Council, in conflict with this Resolution are repealed to the extent of such conflict.

AN ORDINANCE WAIVING COMPETITIVE BIDDING FOR THE PURCHASE OF POLICE VEHICLES FOR USE BY THE ROGERS POLICE DEPARTMENT; PROVIDING FOR THE EMERGENCY CLAUSE; AND FOR OTHER PURPOSES.

WHEREAS, the Rogers Police Department is in need of law enforcement equipped vehicles, and has obtained an offer to purchase the necessary vehicles for a package that includes more than the state bid secured by the Department of Finance and Administration for the same price as the state bid;

WHEREAS, the necessary vehicles include five Traverses and seven Tahoes of various equipment and outfitting packages with striping; and

WHEREAS, the total cost of the purchase of four hundred eighty-one thousand three hundred twenty thousand dollars (\$481,320.00) was approved and budgeted in the City of Rogers 2018 Budget.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ROGERS, ARKANSAS THAT:

<u>Section 1</u>: There exists an exceptional circumstance whereby the requirements of competitive bidding are neither practical nor feasible and the City Council, therefore, waives the requirements of competitive bidding for the purchase of five Traverses and seven Tahoes for use by the Rogers Police Department;

<u>Section 2 - Emergency Clause</u>: The need to acquire quality protective gear for the Rogers Police Force is immediate and in order to protect the public peace, health, safety, and welfare an emergency is hereby declared to exist and this Ordinance shall be in full force and effect from the date of its passage and approval;

<u>Section 3 - Severability Provision:</u> If any part of this Ordinance is held invalid, the remainder of this Ordinance shall continue in effect as if such invalid portion never existed; and

<u>Section 4 - Repeal of Conflicting Provisions</u>: All ordinances, resolutions or orders of the City Council, or parts of the same, in conflict with this Ordinance are repealed to the extent of such conflict.

AN ORDINANCE TO AMEND THE CITY OF ROGERS MUNICIPAL CODE CONCERNING DISCHARGE OF FIREARMS; TO ALLOW CITIZENS OF ROGERS WHO WERE ANNEXED IN BY AN ELECTION TO CONTINUE TO SAFELY DISCHARGE FIREARMS ON THEIR PROPERTY; TO DECLARE AN EMERGENCY; AND FOR OTHER PURPOSES.

WHEREAS, shooting was safely and legally taking place on certain properties before they were annexed into the City of Rogers by election; and

WHEREAS, the annexation itself, in an absence of a change in use or characteristic of the land, does not render the discharge of firearms within the city limits to be unsafe, and property owners should be allowed to continue to practice safe and legal gun practices on their property after the annexation by election;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ROGERS THAT:

Section 1: Section 34-1, "Firearms and weapons; discharging.", is repealed, is replaced, and shall read as follows in the attached Exhibit "A".

<u>Section 2 - Emergency Clause:</u> That for the reasons stated in this Ordinance, and in respect for the Second Amendment rights of the citizens who were annexed in by election, the need to effectuate this ordinance is immediate and in order to protect the public peace, health, safety, and welfare an emergency is hereby declared to exist and this Ordinance shall be in full force and effect on and after its date of adoption;

<u>Section 3 - Severability Provision:</u> If any part of this Ordinance is held invalid, the remainder of this Ordinance shall continue in effect as if such invalid portion never existed; and

<u>Section 4 - Repeal of Conflicting Provisions</u>: All ordinances, resolutions, or orders of the City Council, or parts of the same, in conflict with this Ordinance are repealed to the extent of such conflict.

Exhibit "A"

Sec. 34-1. - Firearms and weapons; discharging.

(a) No person shall shoot or discharge any firearms of whatever name, size or description within the city except:

(1) In the design, testing and manufacturing of firearms by a licensed manufacturer and only in a place so designed and constructed where the projectile cannot escape the confines thereof;

(2) In an indoor public or private shooting range and only in a place so designed and constructed where the projectile cannot escape the confines thereof;

(3) In an outdoor public or private shooting range which has been reviewed by the police department and approved by the public safety committee of the city council; or

(4) As provided for in subsection (b) of this section.

(b) A person may shoot or discharge a firearm within the city if:

(1) The property on which the shooting or discharge takes place was annexed into the city by an election;

(2) On or after the annexation, the property has not transferred ownership, been rezoned, had a change in use adopted by the City of Rogers or the City of Rogers Planning Commission, or had its boundaries adjusted, split, or altered;

(3) The shooting or discharge of the firearm complies with all applicable state and federal laws; and

(4) The shooting or discharge of the firearm complies with all county restrictions on shooting or discharge of the firearm that were in place at the time of the annexation.

I represent Generations Bank. I am writing to take appeal from the January decision of the Rogers Planning Commission to the City Council with respect to the Planning Commission's approval of a conditional use application made by Kyle M. Proctor in conjunction with a proposed car wash to be located at 3711 Southern Hills Blvd. (the "Property") in the C-2 (Highway Commercial) zoning district. The reasons for the appeal include:

1. Generations Bank is the neighboring property owner across Southern Hills Boulevard. The bank is located at 3710 W. Southern Hills. Generations Bank's property is within 300 feet of the Property, and Generations Bank was entitled to mailed notice of the conditional use application pursuant to § 14-723(a)(2) of the Rogers Code of Ordinances. Generations Bank was informed that an attempted mailing of notice to First Bank at Generations' address was returned as undeliverable, and no follow-up efforts to give notice were made. Had Generations received notice, it would have retained counsel to oppose the application before the Planning Commission;

2. The proposed use is incompatible with the adjacent properties and incongruent with the City's master land use plan; and

3. The intersection of W. Southern Hills and Pleasant Grove Road is not controlled by a traffic signal. Pleasant Grove Road is the primary corridor between the interstate and a large scale highly populated residential area. The feasibility of the proposed use depends upon high traffic volumes, and uncontrolled egress from the Property across Pleasant Grove Road creates an unreasonable traffic hazard.
