ORDINANCE NO. 20

AN ORDINANCE ADOPTING CHANGES TO THE SCHEDULE OF USES PROMULGATED BY THE ROGERS PLANNING COMMISSION SINCE APRIL OF 2018; AMENDING CERTAIN PROVISIONS RELATED TO THE SCHEDULE OF USES; PROVIDING FOR THE EMERGENCY CLAUSE; AND FOR OTHER PURPOSES.

- **WHEREAS**, under the Code of Ordinances, City of Rogers, Arkansas §14-721(g) the Planning Commission may update the schedule of uses throughout the year; and
- **WHEREAS**, the Planning Commission has approved several updates to the schedule of uses that need ratification by the City Council to be codified the Code of Ordinances;

NOW, THEREFORE, BE IT ORDAINED, BY THE CITY COUNCIL OF THE CITY OF ROGERS, ARKANSAS:

- **SECTION 1**: The use classification "Real Estate Office" is adopted as a conditional use in the R-AH, N-R, and R-DP zoning districts;
- **SECTION 2**: The use classification "Multifamily Residential (above the first floor)" is adopted as a conditional use in the C-2, C-3, C-4, O, and R-O zoning districts;
- **SECTION 3**: The use classifications "Finance, insurance, and real estate establishments including banks, credit unions, real estate, and property management services, with drive through facilities," "Food service uses such as full-service restaurants, cafeterias, bakeries catering and snack bars with drive through facilities," and "Retail sales or service with drive through facilities" are adopted as permitted by right in the U-COM zoning district;
- **SECTION 4**: The use classification "Commercial Assembly, Recreation, and Entertainment" is adopted as a conditional use in the C-3 zoning district;
- **SECTION 5**: All commercial uses in the Downtown and Uptown Rogers Development Codes are adopted as conditional uses in the NBT and U-NBT zoning districts;
- **SECTION 6**: The use classification "Clubs and Lodges" is adopted as permitted by right in the C-2 and C-4 zoning districts;
- **SECTION 7**: The use classification "Cottage Court/Cluster Housing" is adopted as permitted by right in the N-R zoning district, and the use classifications "Manufactured Housing Unit" and "Mobile Home" are removed from the N-R zoning district;
- **SECTION 8**: The use classification "Accessory building residential unit" is adopted as permitted by right in the COR and COM zoning districts with the use criteria that "Any legally nonconforming detached single-family use may add an accessory unit without violating nonconformity standards.";
- **SECTION 9**: Municipal Code Corporation is directed to codify Sections 1 through 8 of this Ordinance by making the appropriate changes to the use classification tables and related code sections contained within Chapter 14, Article 6, Division 2 of the City of Rogers, Arkansas Code of Ordinances;
- <u>SECTION 10 Emergency Clause:</u> The need to adopt these changes is immediate and in order to protect the public peace, health, safety, and welfare and emergency is declared to exist and this Ordinance shall be in full force and effect from the date of its passage and approval;

<u>SECTION 11 – Severability Provisions</u>: If any part of this Ordinance is held invalid, the remainder of this Ordinance shall continue in effect as if such invalid portion never existed; and

<u>SECTION 12 – Repeal of Conflicting Provisions</u>: All ordinances, resolutions, or orders of the City Council, or parts of the same, in conflict with this Ordinance are repealed to the extent of such conflict.

A RESOLUTION AUTHORIZING THE MAYOR AND CITY CLERK TO ENTER INTO A CONTRACT WITH NATURAL STATE STREAMS, LLC, OF LITTLE ROCK, ARKANSAS, FOR RESTORATION WORK ASSOCIATED WITH THE PINNACLE HILLS OPEN SPACE PROJECT; ACCEPTING THE LOWEST QUALIFIED BID FOR ONE HUNDRED SIXTY-FOUR THOUSAND NINE HUNDRED TEN DOLLARS (\$164,910.00); AND FOR OTHER PURPOSES.

WHEREAS, bids were lawfully requested and submitted for the Osage Creek Natural Area Stream Restoration;

WHEREAS, Natural State Streams, LLC, of Little Rock, Arkansas, submitted the lowest qualified bid in the amount of one hundred sixty-four thousand nine hundred ten dollars (\$164,910.00); and

WHEREAS, this contract is part of the Pinnacle Hills Open Space Project which was authorized and funded by R-17-72, it will be paid for out of grant funds received.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ROGERS, **ARKANSAS THAT**:

Section 1: Natural State Streams, LLC, of Little Rock, Arkansas, is the lowest qualified bid for the Osage Creek Natural Area Stream Restoration:

Section 2: The Mayor and City Clerk are authorized to enter into a contract with Natural State Streams, of Little Rock, Arkansas, for restoration work for this portion of the Pinnacle Hills Open Space Project in the amount of one hundred sixty-four thousand nine hundred ten dollars (\$164,910.00);

Section 3: The Mayor may execute all agreements necessary for the design, construction, inspection, observation, acquisition, materials, testing, and surveying necessary for or attendant to the Osage Creek Natural Area Stream Restoration;

Section 4 - Severability Provision: If any part of this Resolution is held invalid, the remainder of this Resolution shall continue in effect as if such invalid portion never existed; and

Section 5 - Repeal of Conflicting Resolutions: All Resolutions of the City Council, or parts of Resolutions of the City Council, in conflict herewith are hereby repealed to the extent of such conflict.

<u>Section 2: Severability Provision</u> - If any part of this Resolution is held invalid, the remainder of this Resolution shall continue in effect as if such invalid portion never existed; and

<u>Section 3: Repeal of Conflicting Resolutions</u> - All resolutions or orders of the City Council, or parts of resolutions or orders of the City Council, in conflict with this Resolution are repealed to the extent of such conflict.
