AN ORDINANCE AUTHORIZING THE MAYOR AND CITY CLERK TO FILE A CLEAN-UP LIEN FOR THE REMOVAL OF A NUISANCE STRUCTURE AT 1602 SOUTH 1ST STREET LOCATED WITHIN THE CITY OF ROGERS, BENTON COUNTY, ARKANSAS; PROVIDING FOR THE EMERGENCY CLAUSE; AND FOR OTHER PURPOSES.

WHEREAS, the following real property located in Rogers, Benton County, Arkansas, is owned as set out below:

WHEREAS, the property owner of record failed to abate and remedy the nuisance structure on this property, and as a result, the City of Rogers abated the nuisance conditions on the property and incurred the following costs:

WHEREAS, the property owner has been given at least thirty (30) days' written notice of the public hearing in accordance with Ark. Code Ann. §14-54-903; and

WHEREAS, Ark. Code Ann. §14-54-904 authorizes the City Council to assert a clean-up lien on this property to collect the amounts expended by the City in abating and cleaning up the property.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ROGERS, ARKANSAS THAT:

Section 1: Pursuant to Ark. Code Ann. §14-54-904, the City Council certifies that the following real property shall have a lien placed in the records of the Benton County Tax Collector as delinquent taxes and collected accordingly:
