AN ORDINANCE WAIVING COMPETITIVE BIDDING FOR THE PURCHASE OF PHONESOAP MED PRO UNITS AND ASSOCIATED EQUIPMENT AND WARRANTIES FROM PHONESOAP, LLC OF PROVO, UTAH; ALLOWING THE MAYOR AND CITY CLERK TO ENTER INTO A CONTRACT FOR SAID PURCHASE; PROVIDING FOR THE EMERGENCY CLAUSE; AND FOR OTHER PURPOSES.

**WHEREAS**, the City of Rogers desires to purchase twenty-five (25) PhoneSoap Med Pro units and associated equipment and warranties for use at all City facilities;

**WHEREAS**, the purchase of these PhoneSoap Med Pro units and associated equipment and warranties are for the use of cleaning City employee's cellphones, tablets, and other associated technology equipment;

**WHEREAS**, PhoneSoap, LLC of Provo, Utah is the only manufacturer that provides this type of UV disinfectant unit that sanitizes large technology devises at a consistent 360 degrees, ensuring all external surfaces are receiving the UV disinfection for the shared use of devices that will be disinfected; and

**WHEREAS,** PhoneSoap, LLC of Provo, Utah is further the only manufacturer that provides medical grade UV disinfection as a touchless device.

### NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ROGERS, ARKANSAS THAT:

Section 1: That the Mayor and City Clerk are authorized to enter into a contract with PhoneSoap, LLC of Provo, Utah in the amount of fifty-five thousand two hundred forty-five dollars and twenty-one cents (\$55,245.21), for the purchase of twenty-five (25) PhoneSoap Med Pro units and associated equipment and warranties;

Section 2: There exists an exceptional circumstance whereby the requirements of competitive bidding are neither practical nor feasible and the City Council, therefore, waives the requirements of competitive bidding for the purchase of PhoneSoap Med Pro units for use by City of Rogers employees;

# AN ORDINANCE AMENDING VARIOUS SECTIONS OF CHAPTER 14 OF THE CITY OF ROGERS CODE OF ORDINANCES; PROVIDING FOR THE EMERGENCY CLAUSE; AND FOR OTHER PURPOSES.

**WHEREAS**, the City of Rogers' City Council finds it to be in the best interest of the City to update the provisions governing preliminary grading permits as found in Chapter 14 of its Code of Ordinances.

# NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ROGERS, ARKANSAS THAT:

- <u>Section 1</u>: Chapter 14, Section 14-1, of the Code of Ordinances, City of Rogers, Arkansas, is amended to read as shown in the attached Exhibit "A";
- Section 2: Chapter 14, Section 14-796, subsection (d)(7) of the Code of Ordinances, City of Rogers, Arkansas, is amended to read as shown in the attached Exhibit "A";
- Section 3: Chapter 14, Section 14-796, subsection (o)(1-4) of the Code of Ordinances, City of Rogers, Arkansas, is added and should read as shown in the attached Exhibit "A";
- <u>Section 4: Emergency Clause</u>: The need to amend said City Code chapter is immediate in order to protect the public peace, health, safety, and welfare. An emergency is hereby declared to exist and this Ordinance shall be in full force and effect from the date of passage and approval;
- <u>Section 5: Severability Provision</u>: If any part of this Ordinance is held invalid, the remainder of this Ordinance shall continue in effect as if such invalid portion never existed; and
- <u>Section 6: Repeal of Conflicting Provisions</u>: All ordinances, resolutions or orders of the City Council, or parts of the same, in conflict with this Ordinance are repealed to the extent of such conflict.

#### EXHIBIT "A"

#### Sec. 14-1 Definitions

"Completion of Construction" means any Construction Site with a Grading Permit in which

- (1) Development and grading within the disturbed area is complete or approved by the City Engineer to submit a Performance Bond, and matches plans as approved by the Planning Commission;
- (2) The disturbed soil area is observed to have 80% grass coverage and 100% stability;
- (3) No slopes steeper than a 3:1 pitch unless otherwise approved in writing by the City Engineer;
- (4) Notice of Violations issued have all corrective actions approved with an inspection report signed by the City Engineer; and
- (5) All heavy equipment, stockpiles, and construction site materials have been removed from the Construction Site.

#### Sec. 14-796 - Grading permit and tree preservation.

- (d) Grading permit required
  - (7) Approval may be obtained by public or private entities for the stockpiling of construction spoil material at particular locations for a limited time period, not to exceed six months. An additional six month extension may be granted by written approval of the City Engineer. Grading and replanting of grassed areas is required upon removal of stockpile.

#### Sec. 14-796 - Grading permit and tree preservation.

- (o) *Preliminary Grading Permit*. All rules governing the issuance of a grading permit apply with the following exceptions and requirements:
  - (1) The City Engineer may on a limited basis issue a Preliminary Grading Permit to allow clearing, filling, excavating, demolition or similar activities if
    - a. The project has been approved by the Planning Commission; or
    - b. The application does not contain any waiver or variance requests that may change the grading at the location; and
    - c. The applicant has displayed a hardship outside of the normal requirements of code.
  - (2) No construction, to include, but not limited to, foundation work on structures, vehicular use areas, development, or improvements of any kind are authorized by the issuance of a Preliminary Grading Permit.
  - (3) A Preliminary Grading Permit Application must include a grading and drainage plan-and a copy of the ADEQ NOI permit as described above in this Section.
  - (4) Preliminary Grading Permits must be secured by a bond in the amount appropriate to restore the site to a Completion of Construction standard.
  - (5) A Preliminary Grading Permit will expire six (6) months after date of issuance, and must meet the defined Completion of Construction portions 2, 3, 4, and 5, or must be converted to a full Grading Permit,
  - (6) A Preliminary Grading Permit may be converted into a full Grading Permit without an additional fee when the project has received approval through the planning process.

#### AN ORDINANCE AMENDING ROGERS CODE SECTION 14-675 BY RE-ZONING CERTAIN LANDS FROM N-R TO NBT, PROVIDING FOR THE EMERGENCY CLAUSE AND FOR OTHER PURPOSES

**WHEREAS**, pursuant to the provisions of Rogers Code Section Rogers Code Section 14-725, et seq, and upon the consideration of the report and recommendations of the Planning Commission of the City of Rogers, Benton County, Arkansas, on July 7, 2020, the City Council has found that certain lands hereinafter described are better suited for NBT zoning.

### NOW, THEREFORE, BE IT ORDAINED, BY THE CITY COUNCIL OF THE CITY OF ROGERS, ARKANSAS:

<u>SECTION 1</u>: That Section 14-675 of the Code of Ordinances, City of Rogers, should be and the same hereby is amended as hereinafter provided.

<u>SECTION 2</u>: That the land hereinafter described should be and the same is hereby zoned as NBT and that said lands being in Benton County, Arkansas, are described as:

#### PROPERTY DESCRIPTION:

The South 50 feet of the North 100 feet of the E1/2 of Lot 1 in Block 5 in J. Wade Sikes Park Addition, to the City of Rogers, Benton County Arkansas.

#### LAYMAN'S DESCRIPTION:

606 S. 4th Street

- <u>SECTION 3</u>: **Zoning**. That the above described lands are better suited for NBT than N-R zoning and same should be and are hereby zoned NBT.
- <u>SECTION 4</u>: **Emergency Clause**. That it is necessary to bring proposed uses of the property into conformance with the Rogers City Zoning Ordinances and because of such an emergency is declared to exist and in order to protect the public peace, health, safety and welfare, this ordinance shall be in full force and effect from the date of its passage and approval.
- SECTION 5: Severability Provision. In the event that any section, paragraph, subdivision, clause, phrase, or other provision or portion of this Ordinance shall be adjudged invalid or unconstitutional, the same shall not affect the validity of this Ordinance as a whole, or any part or provision, other than the part so decided to be invalid or unconstitutional, and the remaining provisions of this Ordinance shall be construed as if such invalid, unenforceable or unconstitutional provision or provisions had never been contained herein.
- <u>SECTION 6:</u> **Repeal of Conflicting Ordinances and Resolutions**. All ordinances, resolutions or orders of the City Council, or parts of ordinances, resolutions or orders of the City Council in conflict herewith are hereby repealed to the extent of such conflict.

<u>Section 1</u>: Chapter 20, Section 26 of the Code of Ordinances, City of Rogers, Arkansas, is hereby revoked and removed from the City of Rogers Code of Ordinances;

<u>Section 2: Emergency Clause</u>: The need to remove said City Code chapter is immediate in order to protect the public peace, health, safety, and welfare. An emergency is hereby declared to exist and this Ordinance shall be in full force and effect from the date of passage and approval;

<u>Section 3: Severability Provision</u>: If any part of this Ordinance is held invalid, the remainder of this Ordinance shall continue in effect as if such invalid portion never existed; and

<u>Section 4: Repeal of Conflicting Provisions</u>: All ordinances, resolutions, or orders of the City Council, or parts of the same, in conflict with this Ordinance are repealed to the extent of such conflict.

AN ORDINANCE WAIVING COMPETITIVE BIDDING FOR THE PURCHASE OF A PORTABLE TRAINING SYSTEM FROM ULTIMATE TRAINING MUNITIONS OF NORTH BRANCH, NEW JERSEY; ALLOWING THE MAYOR AND CITY CLERK TO ENTER INTO A CONTRACT FOR SAID PURCHASE; PROVIDING FOR THE EMERGENCY CLAUSE; AND FOR OTHER PURPOSES.
