# AN ORDINANCE WAIVING COMPETITIVE BIDDING FOR THE PURCHASE OF A USED 2020 JOHN DEERE 544 LOADER FOR USE BY THE CITY OF ROGERS' STREET DEPARTMENT; PROVIDING FOR THE EMERGENCY CLAUSE; AND FOR OTHER PURPOSES.

WHEREAS, Benton County has discontinued its operation of the Yard Waste Disposal Center;

**WHEREAS**, the City of Rogers plans to keep the Yard Waste Disposal Center operational for City of Rogers' residents only for the remainder of the year;

**WHEREAS**, the City of Rogers' Street Department wishes to purchase a used 2020 John Deere 544 Loader (hereinafter "Loader") for use at the Yard Waste Disposal Center;

**WHEREAS**, Stribling Equipment, LLC of Little Rock, Arkansas, has agreed to a purchase price for the Loader at one hundred seventy-nine thousand one hundred one dollars and fifty six cents (\$179,101.56); and

WHEREAS, the Loader is a used unit and therefore the use of competitive bidding is neither practical nor feasible.

### NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ROGERS, ARKANSAS THAT:

Section 1: There exists an exceptional circumstance whereby the requirements of competitive bidding are neither practical nor feasible and the City Council, therefore, waives the requirements of competitive bidding for the purchase of a used 2020 John Deere 544 Loader for use by the City of Rogers' Street Department;

Section 2: The City agrees to purchase the Loader from Stribling Equipment, LLC of Little Rock, Arkansas for the purchase price of one hundred seventy-nine thousand one hundred one dollars and fifty six cents (\$179,101.56);

Section 3: Emergency Clause: The need to acquire and the availability of the used Loader is immediate and an emergency is hereby declared to exist and this Ordinance shall be in full force and effect from the date of its passage and approval;

<u>Section 4: Severability Provision</u>: If any part of this Ordinance is held invalid, the remainder of this Ordinance shall continue in effect as if such invalid portion never existed; and

<u>Section 5: Repeal of Conflicting Provisions</u>: All ordinances, resolutions or orders of the City Council, or parts of the same, in conflict with this Ordinance are repealed to the extent of such conflict.

A RESOLUTION AMENDING THE 2020 BUDGET TO RECOGNIZE LEASE REVENUE IN THE AMOUNT OF ONE HUNDRED FIFTY-EIGHT THOUSAND FOUR HUNDRED DOLLARS (\$158,400.00) INTO ACCOUNT #200-16-49400 RENTAL INCOME; APPROPRIATING ONE HUNDRED EIGHTY-NINE THOUSAND EIGHT HUNDRED TWENTY-THREE DOLLARS (\$189,823.00) TO ACCOUNT # 200-16-80100 CAPITAL EXPENDITURES FROM RENTAL REVENUE AND STREET FUND RESERVES; AND FOR OTHER PURPOSES.

**WHEREAS**, the City of Rogers receives \$19,800.00 monthly in lease revenue from a lease agreement between the City of Rogers and The Recon Group, LLC for property located within the Rogers Street Department building; and

**WHEREAS**, the City of Rogers' Street Department desires to amend the 2020 Budget and recognize this rental revenue and appropriate additional street fund reserves to purchase a used loader for \$179,101.56.

**WHEREAS**, the City needs to appropriate an additional \$10,721.38 to the 2020 budgeted purchase of a tri-axle dump truck which was budgeted in 2020 at \$150,000; however, the actual purchase price of the used tri-axle dump truck is \$160,721.38, which necessitates the need for the additional appropriation.

## NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ROGERS, ARKANSAS THAT:

<u>Section 1</u>: The 2020 Budget is hereby amended to recognize lease revenue in the amount of one hundred fifty-eight thousand four hundred dollars (\$158,400.00) to Account #200-16-49400 Rental Income;

<u>Section 2</u>: The 2020 Budget is further amended to appropriate one hundred eighty-nine thousand eight hundred twenty-three dollars (\$189,823.00) from Account #200-16-49400 Rental Income and Street Fund Reserves to Account #200-16-80100 Capital Expenditures;

<u>Section 3: Severability Provision</u>: If any part of this Resolution is held invalid, the remainder of this Resolution shall continue in effect as if such invalid portion never existed.

A RESOLUTION APPROVING MITCHELL, WILLIAMS, SELIG, GATES & WOODYARD, P.L.L.C. TO PROVIDE BOND COUNSEL SERVICES TO THE ROGERS WATER UTILITIES, THE ROGERS WATERWORKS AND SEWER COMMISSION AND THE CITY OF ROGERS WITH RESPECT TO OPTIONAL REDEMPTION OF CERTAIN SEWER BONDS ISSUED BY THE CITY OF ROGERS AND TO PROVIDE OTHER ASSISTANCE TO THE ROGERS WATER UTILITIES AS REQUESTED; AUTHORIZING THE ROGERS WATER UTILITIES AND THE ROGERS WATERWORKS AND SEWER COMMISSION TO SELECT AND ENGAGE OTHER PROFESSIONALS AND/OR PROFESSIONAL SERVICE FIRMS TO ACCOMPLISH OPTIONAL REDEMPTION OF THE BONDS; AND FOR OTHER PURPOSES

WHEREAS, the Rogers Water Utilities and the Rogers Waterworks and Sewer Commission have issued that certain Request for Qualifications (RFQ) dated July 29, 2020, seeking bond counsel services to provide advice and assistance with regard to optional redemption of certain sewer bonds issued by the City of Rogers, Arkansas, namely that certain series of bonds known as the \$3,310,000 City of Rogers Arkansas, Sewer Revenue Bonds Series 2010 ("the Bonds"); and RWU also seeks bond counsel to provide additional legal counsel and assistance as requested during fiscal year 2021; and

**WHEREAS**, having reviewed the submissions made in response to the RFQ, the Rogers Waterworks and Sewer Commission has selected Mitchell, Williams, Selig, Gates & Woodyard, P.L.L.C. ("Mitchell Williams") to provide bond counsel services with respect to optional redemption of the Bonds; and to provide additional legal counsel and assistance to RWU as requested during fiscal year 2021.

# NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ROGERS, ARKANSAS:

Section 1: The Rogers City Council hereby approves the selection of Mitchell, Williams, Selig, Gates & Woodyard, P.L.L.C. ("Mitchell Williams") to provide bond counsel services with respect to optional redemption of the Bonds; and to provide additional legal counsel and assistance to RWU as requested during fiscal year 2021 and further authorizes the Rogers Water Utilities and the Rogers Waterworks and Sewer Commission to negotiate a contract with Mitchell Williams, in accordance with Ark. Code. Ann. § 19-11-805 and the specifications of the RFQ.

<u>Section 2:</u> The Rogers Water Utilities and the Rogers Waterworks and Sewer Commission are further authorized, in accordance with applicable law, to select and engage other professionals and/or professional service firms, necessary to accomplish optional redemption of the Bonds.

<u>Section 3:</u> In consultation with Mitchell Williams and/or other professionals, and/or other professional services firms selected, the Rogers Water Utilities and the Rogers Waterworks and Sewer Commission are further authorized to present recommendations for optional redemption, and/or other prudent and appropriate actions, with respect to the Bonds, to the Rogers City Council for approval.

<u>Section 4: Severability Provision:</u> If any part of this Resolution is held invalid, the remainder of this Resolution shall continue in effect as if such invalid portion never existed; and

<u>Section 5: Repeal of Conflicting Resolutions</u>: All ordinances, resolutions, or orders of the City Council, or parts of the same, in conflict with this Resolution are repealed to the extent of such conflict.

**WHEREAS**, the Rogers Fire Department has been awarded a Staffing Adequate Fire and Emergency Response (SAFER) Grant from the US Department of Homeland Security;

**WHEREAS**, the grant will allow for the Rogers Fire Department to hire three (3) additional firefighters to staff Fire Station #2's Heavy Rescue and Hazardous Materials Unit;

**WHEREAS**, the purpose of the Staffing for Adequate Fire and Emergency Response (SAFER) program is to provide grants to fire service agencies to provide financial assistance for firefighter staffing;

**WHEREAS**, the goal of the grant program is to assist local fire departments with staffing and deployment capabilities in order to respond to emergencies, assuring communities have adequate protection from fire and fire related hazards;

**WHEREAS**, SAFER funding will pay 100 percent (100%) of the salary and benefit costs for newly hired firefighters (exclusive of overtime) for three years; and

**WHEREAS**, if accepted, this grant will allow the fire department to respond with sufficient personnel in meeting applicable OSHA standards;

# NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ROGERS, ARKANSAS THAT:
