ORDINANCE NO. 18-____

AN ORDINANCE PROVIDING FOR THE ACQUISITION OF REAL PROPERTY AND ANY INTEREST IN ANY REAL PROPERTY TO FACILITATE STREET IMPROVEMENTS AND OTHER PROJECTS PURSUANT TO THE 2018 CITY OF ROGERS BOND ISSUE; AUTHORIZING CERTAIN CONTRACTS AND LEASE CONTRACTS TO FACILITATE PROJECTS PURSUANT TO THE 2018 CITY OF ROGERS BOND ISSUE; PROVIDING FOR THE EMERGENCY CLAUSE; AND FOR OTHER PURPOSES.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ROGERS, ARKANSAS THAT:

<u>Section 1</u>: The City of Rogers Mayor and Community Development, Streets, Parks, Police, Fire, and Legal Departments, and any authorized agents thereof, are hereby authorized to take all necessary legal action in obtaining interests in real property in order to facilitate land acquisition for the purposes described in the 2018 Capital Improvement Bond Issue passed by the citizens of the City of Rogers, and to execute all contracts, conveyances, and lease contracts valued at under twenty thousand dollars (\$20,000.00) in furtherance of the projects described in the 2018 Capital Improvement Bond Issue passed by the citizens of the City of Rogers;

<u>Section 2</u>: This authority shall include, but not be limited to purchasing, negotiation, bargaining, trading, and, if necessary, the institution of Eminent Domain Causes of Action necessary to accomplish improvements authorized by said Bond Issue;

<u>Section 3 - Emergency Clause</u>: The need to acquire necessary property is immediate and in order to protect the public peace, health, safety, and welfare an emergency is hereby declared to exist and this ordinance shall be in full force and effect from the date of its passage and approval.

<u>Section 4 - Severability Provision</u>: If any part of this Ordinance is held invalid, the remainder of the Ordinance shall continue in effect as if such invalid portion never existed; and

<u>Section 5 - Repeal of Conflicting Ordinances and Resolutions</u>: All ordinances, resolutions or orders of the City Council, or parts of the same, in conflict with this Ordinance are repealed to the extent of such conflict.

A RESOLUTION AUTHORIZING THE MAYOR AND CITY CLERK TO ENTER A CONTRACT AMENDMENT WITH GARVER, LLC. OF NORTH LITTLE ROCK, ARKANSAS IN THE AMOUNT OF FORTY-FIVE THOUSAND DOLLARS (\$45,000.00); AND FOR OTHER PURPOSES.

WHEREAS, the City of Rogers Executive Airport has received a grant from the Federal Aviation Administration to construct a Taxilane-Apron at the Rogers Executive Airport;

WHEREAS, Garver, LLC is the engineer of record for design and construction phase services for this project; and

WHEREAS, construction is expected to exceed original contract time and the extension of construction phase services is required for project completion.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ROGERS, ARKANSAS THAT:

ORDINANCE NO. 18-____

AN ORDINANCE PROVIDING FOR THE AUTHORIZATION OF ADDITIONAL LEGAL SERVICES FOR COMPENSATION TO BE PROVIDED BY THE OFFICE OF THE CITY ATTORNEY; PROVIDING FOR THE EMERGENCY CLAUSE AND FOR OTHER PURPOSES.

WHEREAS, Sec. 2-203(d) of the Code of Ordinances, City of Rogers, Arkansas states that the City Attorney "shall perform such duties, and another other duties as assigned by the city council";

WHEREAS, Ark. Code. Ann. §14-43-410(b)(1)(A) states "by proper ordinance, any city or town may specify pay for the city attorney as council may desire"; and

WHEREAS, from time to time, it may be necessary for the City Attorney to assist the City of Rogers Legal Department with legal issues that arise.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ROGERS, ARKANSAS:

<u>Section 1</u>: That the City Attorney is authorized by the Rogers City Council to consult with and assist the City of Rogers Legal Department when the need arises.

<u>Section 2</u>: That City of Rogers Legal Department is authorized to compensate the City Attorney for legal services as needed at the billable rate of two hundred fifty dollars (\$250.00) per hour.

<u>Section 3 - Emergency Clause</u>: That the need for said authorization is immediate and in order to protect the public peace, health, safety and welfare an emergency is hereby declared to exist and this Ordinance shall be in full force and effect from the date of its passage and approval.

<u>Section 4 - Severability Provision</u>: If any part of this Ordinance is held invalid, the remainder of the Ordinance shall continue in effect as if such invalid portion never existed; and

<u>Section 5 - Repeal of Conflicting Ordinances and Resolutions</u>: All ordinances, resolutions or orders of the City Council, or parts of the same, in conflict with this Ordinance are repealed to the extent of such conflict.

- (b) Audited records seven years or older: completed case files and written exhibits, show cause orders, case information including arrest reports and affidavits, files concerning cases resulting in a suspended imposition of sentence.

<u>Section 2 - Severability Provision</u>: If any part of this Resolution is held invalid, the remainder of this Resolution shall continue in effect as if such invalid portion never existed; and

<u>Section 3 - Repeal of Conflicting Resolutions</u>: All resolutions or orders of the City Council, or parts of resolutions or orders of the City Council, in conflict with this Resolution are repealed to the extent of such conflict.

AN ORDINANCE AMENDING ROGERS CODE SECTION 14-675 BY RE-ZONING CERTAIN LANDS FROM RSF TO R-DP PROVIDING FOR THE EMERGENCY CLAUSE AND FOR OTHER PURPOSES

WHEREAS, pursuant to the provisions of Rogers Code Section Rogers Code Section 14-725, et seq, and upon the consideration of the report and recommendations of the Planning Commission of the City of Rogers, Benton County, Arkansas, the City Council has found that certain lands hereinafter described are better suited for R-DP than RSF zoning.

NOW, THEREFORE, BE IT ORDAINED, BY THE CITY COUNCIL OF THE CITY OF ROGERS, ARKANSAS:

AN ORDINANCE AMENDING ROGERS CODE SECTION 14-675 BY RE-ZONING CERTAIN LANDS FROM C-2 (HIGHWAY COMMERCIAL) TO U-COM (UPTOWN COMMERCIAL MIXED USE)

WHEREAS, pursuant to the provisions of Rogers Code Section 14-725, et seq, and upon the consideration of the report and recommendations of the Planning Commission of the City of Rogers, Benton County, Arkansas, the City Council has found that certain lands hereinafter described are better suited for U-COM (Uptown Commercial Mixed Use) than C-2 (Highway Commercial) zoning.

NOW, THEREFORE, BE IT ORDAINED, BY THE CITY COUNCIL OF THE CITY OF ROGERS, ARKANSAS:

SECTION 1: That Section 14-675 of the Code of Ordinances, City of Rogers, should be and the same hereby is amended as hereafter provided.

SECTION 2: That the land hereinafter described should be and the same is hereby zoned as U-COM and that said lands being in Benton County, Arkansas, are described as:

AN ORDINANCE AMENDING ROGERS CODE SECTION 14-675 BY RE-ZONING CERTAIN LANDS FROM A-1 AND RSF TO C-3, PROVIDING FOR THE EMERGENCY CLAUSE AND FOR OTHER PURPOSES

WHEREAS, pursuant to the provisions of Rogers Code Section Rogers Code Section 14-725, et seq, and upon the consideration of the report and recommendations of the Planning Commission of the City of Rogers, Benton County, Arkansas, the City Council has found that certain lands hereinafter described are better suited for C-3 than A-1 and RSF zoning.

NOW, THEREFORE, BE IT ORDAINED, BY THE CITY COUNCIL OF THE CITY OF ROGERS, ARKANSAS:

SECTION 1: That Section 14-675 of the code of Ordinances, City of Rogers, should be and the same hereby is amended as hereinafter provided.
