White, largest grant from Walton Family Foundation for trees, plotter software & maintenance.

RES. R20-84. Authorizing The Mayor And City Clerk To Sign An Abandonment Of The Temporary Construction Easement Granted By Warren Family, LLC

The resolution was introduced by Kruger and read by title only by City Attorney Andrew Hatfield.

Carmichael, chair of Community Environment & Welfare Committee, reported the committee had met, recommended a "Do pass" and recognized Engineer Lance Jobe.

Jobe, wording on easement from the expansion of Perry Road. Currently reads doesn't expire until abandoned, asking for abandonment.

No questions from the council.

Motion by Hayes, second by Reithemeyer to adopt the resolution.

ORD. #20-95. Amending Rogers Code Section 14-675 By Re-Zoning Certain Lands From RMF-9A (PUD) To RMF-12A, Accepting The Density Concept Plan (Everest)

The ordinance was introduced by Carmichael and read by title only by City Attorney Andrew Hatfield.

Carmichael, chair of Community Environment & Welfare Committee, reported the committee had met, recommended to "Do pass" and recognized Geoff Bates.

Bates, representing developer in project on 4 acres allowing for 12 units per acres. In line with comprehensive growth map and recommended for approval by staff.

Kruger, cannot support rezone due to the density of the project on the land proposed.

Reithemeyer, cannot support and notes the original staff report was not in favor of this development.

Wolf, has a tough time supporting this rezone.

Carmichael, all points brought to light have been addressed and discussed in Planning Commission. Last piece of land to be developed and adjacent properties are compatible with the development.

Mayor, during Planning Commission was the comment of previous developments on the adjoining properties a mistake an opinion?

Carmichael, project has been to the Planning Commission 3 times and was a split vote and main concern was rear facing.

Bates, unique property because it is completely surrounded by streets hence the rear facing.

The Mayor asked, "Shall the ordinance pass?" Roll call: Kendall, Carmichael, Brashear, Townzen – Yes. Kruger, Reithemeyer, Wolf, Hayes – No. Tie: Mayor – Yes. The ordinance is adopted.

Carmichael, chair of Community Environment & Welfare Committee, reported the committee had met, recommended to "Do pass" and recognized Phil Swope. No questions from the council. The Mayor asked, "Shall the ordinance pass?" Roll call: Unanimous – Yes. The ordinance is adopted. Hayes, reminder to stay safe and smart during this ongoing pandemic. Reithemeyer, budget books will be out for review next week in preparation for the meeting at the Rogers Convention Center. Mayor, vote and assist neighbors, friends, church members in getting to the polls safely.
