Today, the department is a career, full-time, fire department serving through eight fire stations and a training center. The RFD operates as a department within the City of Rogers and is accountable to the Mayor and City Council.

We serve those who live, work, and travel through our city from eight fire stations, which are all staffed 24 hours a day by professionally trained firefighters and paramedics. Although the department continues to evolve with the needs of the community, the Rogers Fire Department remains committed to helping people and protecting our first-class city.











Mutual Aid Responses (2019-2023)











EMS Responses


