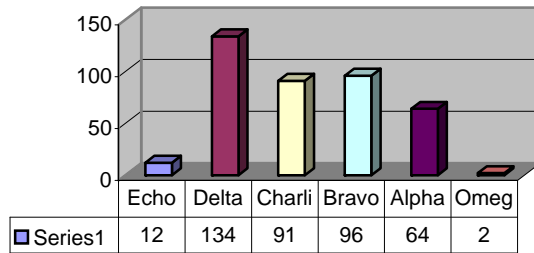

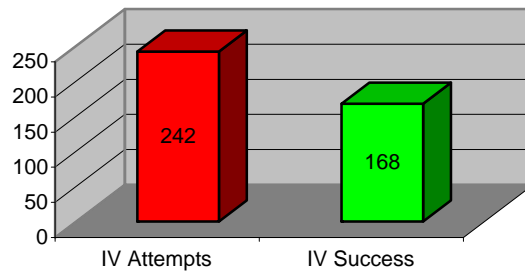

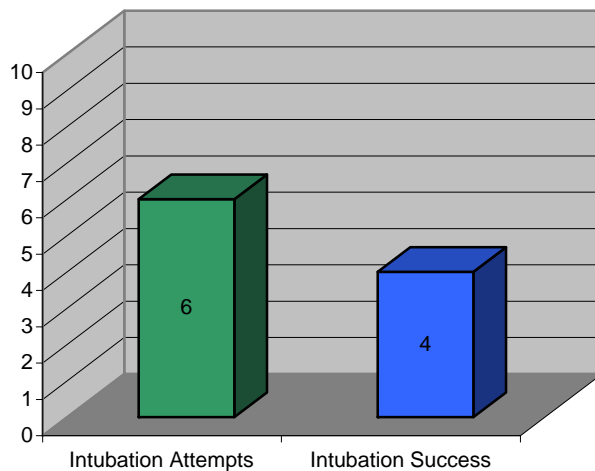
Rogers Fire Department - Emergency Medical Determinants by Classification (August 2012)



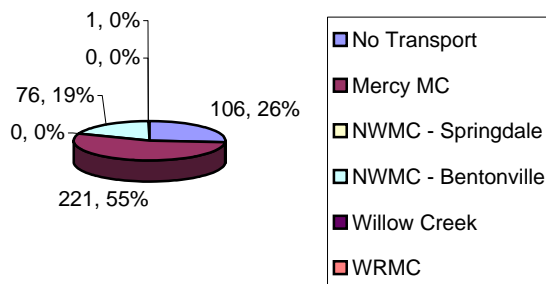
Intervenous Start Performance
